5.2 ASSET MANAGERS MONTHLY REPORT

Bernie Haar (Acting Group Manager Operations) spoke to the committee of Fraser Crescent street lighting issues and residents' concerns of pot holes. Mr Haar advised the contractor has increased visual warnings.

Scott Mckenzie (Roading Manager) has spoken to Netconn regarding lighting issues in Tekapo. Netconn have multiple issues causing this problem. The only way to resolve this is a process of elimination, checking individual light poles. It is being worked on and will take time to resolve. This is a safety concern. Mr Mckenzie will follow this up.

Glen Lyon Road fence, property owners are not required to have a fence on the road boundary. Mr Haar confirmed that access has been removed, but will be monitored by Mr Mckenzie to ensure access is stopped.

Mr Mckenzie updated the committee on logging on Lilybank and Braemar Roads. There is maintenance work under way, and further work planned for Lilybank Road prior to ski season. Hayman and Braemar Roads are looking good. Heavy vehicle restrictions will come into place when the winter weather comes.

Ben Ohau Road, Mr Mackenzie has spoken to Whitestone and asked them to fill the potholes and grade the rotten rock section.

Solid waste, Angie Taylor (Solid Waste Manager) will provide a report for the Assets and Services meeting on 2 July on the figures from the green waste free day.
