#### PURPOSE OF REPORT

Suzanne Blyth (Resource Management Planner – Consents) made the following corrections and clarification to the report, Suzanne Blyth is co-author, and on page 23 of the agenda under the heading "Process to Date" the text should read "This included defining how the travel costs will be determined, defining what a hail search consists of and removing the fee for noise monitoring & noise complaints call outs".

In the Statement of Proposal the following changes have been made:

- All references to "at cost" replaced with "actual cost" to align with the RMA terminology.
- Under the heading "Travel Costs", removed text from sentence to clarify intent and corrected travel rate from 0.67c/km to 0.76c/km.
