5.2 COUNCIL FINANCIAL REPORT

PURPOSE OF REPORT

The Financial reports for Council for the period ending April 2019.

Paul Numan spoke of the new format of the report which is at a higher governance level.

There was discussion around the delay in receiving financial reports due to month end and meeting timings. There is a review in process to improve reporting and staff will investigate producing reports earlier if possible. Meeting timings could also be altered to aid this.

The cap on unplanned funds being granted from the Land Subdivision Fund was discussed. The Chief Executive Officer responded that it is meant for specific purposes. It is for the long term and a reserve for large projects. Council put this limit in place to ensure the money would be used strategically for the district. The cap can be altered if the policy is reviewed.

Councillors would like to see budgeted future costs in the financial report. The concept of a midyear budget review was discussed and will be investigated by the Chief Executive Officer.
