#### 1 OPENING

The chairman opened the meeting and Michael Mcmillan gave a karakia.

The governance advisor noted that this meeting was held fully on Zoom but that Parliament had extended the Epidemic Preparedness (COVID-19) Notice 2020 for a further three months. This included the amendment to enable meetings via audio or visual link to meet quorum requirements regardless of Council Standing Orders.

#### 2 APOLOGIES

Apologies were received from Richard Subtil and Lisa Anderson.

#### 3 DECLARATIONS OF INTEREST

There were no declarations of interest.

#### 4 VISITORS

There were no visitors.

#### 5 REPORTS

### 5.1 MINUTES OF UPPER WAITAKI ZONE WATER MANAGEMENT COMMITTEE MEETING - 21 MAY 2021

#### 5.2 TWIZEL RIVER RESTORATION

Matt Bayliss explained the background to the initiative to carry out river restoration work. Challenges for this area included mixed land ownership and unallocated crown land. The first step is the development of a plan for the area. This required money and help to employ the right set of skills to assist with a plan.

Karina Morrow from the Department of Conservation (DOC) said there was only budget for low level weed control for this particular section of the river due to competing priorities throughout the district. She was supportive of a plan and of another organisation taking the lead on this work. She said DOC was open to the options of vesting land in council or a community agreement and was happy to work with other groups. She did not have anything to financially contribute but was happy to provide expertise.

April Hussey from Toitū Te Whenua Land Information New Zealand (LINZ) said LINZ did not have any land in the area of the proposed restoration work. Unallocated land did not sit with LINZ. There is a process that could be followed to allocate the land but it is lengthy and expensive. LINZ would not be a party to any contracts or agreements regarding the land as they aren't responsible for land in this particular area.

Matt Bayliss suggested the next steps should be to engage with Mackenzie District Council (MDC). Karina Morrow suggested raising this as part of the Parks Strategy consultation process. It was agreed to engage with MDC.

Matt Bayliss offered to organise a meeting with Tim Harty at MDC in the next few weeks.

Cr Stuart Barwood, Karina Morrow and April Hussey left the meeting.

#### 5.3 RUATANIWHA UPDATE

Joy Paterson updated the committee on a meeting of people involved with Lake Ruataniwha. She said there was immense goodwill from them to ensure the water quality issue did not happen again. They will be meeting again in August to review the communications material.

Regarding the need for a permanent toilet, an application for funding had been lodged by Mackenzie District Council and a decision would not be made until the outcome of this was known.

#### 5.4 ZONE FACILITATOR'S REPORT

This report was from Janine Roux, Zone Facilitator, Environment Canterbury. This report provided information of interest to the Zone Committee that was not covered elsewhere in the agenda.

Janine Roux outlined the contents of her report. Cr Ross McRobie confirmed he was assisting with the Omarama Stream planting location. Regarding the committee refresh, there was concern that the new applicant had so far been unable to attend an interview or meeting.

The next meeting was discussed. There was a concern about the TLI numbers coming through and it was suggested that a meeting be held in conjunction with the Ahuriri Catchment Community Group and stakeholders in July to discuss this issue. This would be held at Omarama.

The initial preference was to wait for August to hold the meeting, however the committee heard that farmers in the area preferred July so they could make decisions before irrigation began. The committee agreed to do it in July.

Cr Sunckell asked if it was timely to have a discussion with Benmore Irrigation. Janine Roux said yes, either before or during the public consultation process.

Kate Doran asked if the July meeting would be a workshop or a formal zone committee meeting. The committee preferred a workshop to allow free and frank discussion.

Janine Roux then updated the committee on the Immediate Steps budget. This would no longer exist but would change to a "community engagement fund". The zone committee would have more say over how it would be spent, although the amount would be halved in the first year to \$50,000.

It was noted that member Lisa Anderson finishes her term with the committee at this meeting however, the committee agreed to invite her to the July workshop at Omarama. Her efforts during her time on the committee were acknowledged.

#### 5.5 UPDATE ON TLI RESULTS

Water scientist Graeme Clark updated the zone committee on the latest TLI (Trophic Level Index) results in the upper Waitaki lakes and gave his views on what was causing the TLI increase in the Ahuriri Arm of Lake Benmore. He said they were also keeping an eye on the smaller lakes such as Lake Alexandrina and Lake Middleton.

Extra water sampling was done at Lake Middleton to determine the impact of the fire and work is being done on these samples currently.

Michael Mcmillan asked if Lake Middleton and Alexandrina had any consents tied to them. No, but they are in sensitive lake zones and farmers are required to be working to good management practice.

The role of the calm, warm summer in contributing to the results was discussed. Environment Canterbury's compliance and land management advisor teams were keeping an eye on the affected catchments. Graeme Clark said there was a range of drivers behind any lake result and understanding these was really important.

#### 5.6 ENVIROSCHOOLS, YOUTH ENGAGEMENT AND EDUCATION

Debbie Eddington informed the zone committee about the Youth Engagement & Education and Envrioschools programme undertaken by Environment Canterbury. A copy of her presentation is available as an attachment to these minutes.

The committee discussed working further with Twizel School and this would be followed up.

#### **PURPOSE OF REPORT**

This report is from Viv Smith-Campbell, Chairperson of the Ōhau Conservation Trust and provides an update on Lake Middleton projects by the Ōhau Conservation Trust, working with the Department of Conservation.

#### **BACKGROUND**

In 2019 the Zone Committee visited Lake Middleton to hear about its wide range of values and several issues. There were also discussions about the lake's water quality and access around the lake at a number of committee meetings.

The Ohau Conservation Trust has been working with the relevant organisations over several years to better protect and enhance the lake and its catchment.

Post the October 2020 wildfire, there are now opportunities for projects to achieve this. Viv Smith-Campbell, Chairperson of the Trust will give a short presentation about the Lake Middleton projects it has underway.

#### **PURPOSE OF REPORT**

This report is from Janine Roux, Zone Facilitator, Environment Canterbury.

This report provides information that may be of interest to the Zone Committee that is not covered elsewhere in the agenda.

#### STAFF RECOMMENDATIONS

- 2. That the Action Plan presented be accepted as the Zone Committee's plan for 2021-2024.

#### 1. Zone Committee Action Plan

Zone Committee Action Plans are a new mechanism that has been introduced to help committees focus on the actions they can take.

As attached – the final Upper Waitaki Zone Committee Action Plan which has been developed within the new Terms of Reference, the CWMS and Targets, the Letter of Shared Priorities, Zone Implementation Programmes and its Addendums.

As part of implementing this plan, Zone Committees will have the opportunity to recommend on \$50,000 for the current financial year (FY22). This money is in place of the previous funding Immediate Steps.

#### 2. Zone Committee review update

Environment Canterbury Council, Waimate District Council and Waitaki District Council have signed off the new terms of reference for the Zone Committee. Mackenzie District Council are currently working through the process.

Upper Waitaki Water Zone Committees revised Terms of Reference provided as an attachment.

#### 3. Ruataniwha Camping Ground occupancy numbers

The occupancy numbers from the Holiday Park were received for 2019 and 2020 and showed no significant changes (Approximate numbers):

- 40926 people nights from Sept 2019 to March 2020;
- 37304 people nights from Sept 2020 to March 2021.

Additionally, the ongoing work to increase the number of permanent toilets in the area has had a big win; MDC is set to receive \$680,000 to upgrade toilets, parking areas and lake access at Lake

A working group meeting is being held on 20 August to further actions for 2021/22 Summer.

#### 4. Update following the Ahuriri catchment community meeting

Landowners have received an initial update following the community meeting held in July.

For the request for a non-enforcement to be fully, and properly, considered Environment Canterbury need to ensure that it has had the required review from our senior leadership. A paper for the next available Executive Leadership Team (ELT) Meeting (23rd August) is being prepared, which will include the request for non-enforcement. Once the ELT has made their decision on the paper, it will, if required, be passed to the Council for their consideration and agreement of issues beyond the non-enforcement request.

#### 5. Land and Water Regional Plan proposed Plan Change 7 update

The independent hearing commissioners recently delivered their recommendations on the plan change. In the meantime, the modelling tool Overseer has been undergoing a scientific review by a Science Advisory Panel established by Ministry for Primary Industries and Ministry for the Environment.

Environment Canterbury want to understand the Overseer review outcome, before making a decision on whether to accept the PC7 hearing commissioners' recommendations as their own.

Council has applied to the Minister for the Environment for an extension to the timeframe to make its decision on PC7 and PC2, until 31 October 2021. The commissioners' recommendations will be made public as part of the meeting agenda when the Council decides whether to adopt the recommendations on PC7 and PC2.

#### 6. Government response to the findings of the Overseer peer review report

The report has been released setting out the Governments response to the Science Advisory Panel's independent peer review of the Overseer nutrient management model.

The Parliamentary Commissioner for the Environment, in 2018, outlined what needed to happen for the Overseer model to be used confidently in regulation, including a whole-model peer review of Overseer. That review was undertaken by the Science Advisory Panel appointed by the Ministry for Primary Industries and the Ministry for the Environment.

The Panel concluded they did not have confidence in Overseer's estimates of nitrogen lost from farms across the full range of New Zealand's climate, topographies, and land-uses.

The Government will work to support the development of a next generation Overseer so that it can fully investigate the opportunities and plan an appropriate path for redevelopment.

# CWMS Zone Committees – Revised Terms of Reference 2020

#### Confirmed by Canterbury Regional Council (10 December 2020)

Canterbury Water Management Strategy (CWMS) – Terms of Reference

Upper Waitaki Water Management Zone Committee

#### AREA

The area of the Upper Waitaki Water Management Zone is shown on the attached map.

The Upper Waitaki Water Management Zone includes the takiwā of Te Rūnanga o Arowhenua, Te Rūnanga o Waihao, and Te Rūnanga o Mōeraki and the administrative areas of Waitaki District Council, Mackenzie District Council, and Environment Canterbury.

#### BACKGROUND

The committee is an expression of the partnership between Waitaki District Council, Mackenzie District Council, and Environment Canterbury (the Regional Council), Te Rūnanga o Arowhenua, Te Rūnanga o Waihao, and Te Rūnanga o Mōeraki, and local communities to implement the Canterbury Water Management Strategy.

The committee is established under the auspices of the Local Government Act 2002 in accordance with the Canterbury Water Management Strategy 2009.

The committee is a joint committee of Waitaki District Council, Mackenzie District Council, and Environment Canterbury (the Regional Council).

Relevant Territorial Authority Standing Orders apply to the operation of the committee. This includes requirement to make a declaration of conflict of interest, keeping a register of interests and guidance on attendance and absences at meetings.

The committee will work as a committee and as individual members in accordance with Canterbury Water Management Strategy Zone Committee Code of Conduct.

#### PURPOSE AND FUNCTIONS

The Committee's purpose is to uphold the mana of the freshwater bodies within their zone by facilitating enduring land and water management solutions that give effect to the Canterbury Water Management Strategy vision, principles and targets in their zone.

The committee functions include:

- Facilitating community engagement and collaboration continuing an active programme of engaging with communities on freshwater management matters; and
- b. Facilitating the provision of advice through to councils (relevant Territorial Authorities and Environment Canterbury) and others (e.g. private sector) contributing to freshwater management; and
- c. Enhancing delivery capability and coalition of the willing working with stakeholders across all sectors to extend the resources available to implement the CWMS, including connecting others to additional resources and seeking opportunities to promote, support, leverage and expand catchment-based initiatives that deliver the CWMS; and
- d. Progress Reporting annual progress reporting to CWMS partners on progress towards delivery of the zone-specific priorities and CWMS target areas identified in the Zone Committee Action Plan.

#### ZONE COMMITTEE ACTION PLAN AND PROGRESS REPORT

- Ensure the purpose and functions of the committee are fulfilled by preparing a Zone Committee Action Plan that:
  - a. Covers a three-year period
  - b. Focuses on three five priorities
  - c. States objectives that the zone committee is seeking to achieve
  - States the actions that the zone committee will take to achieve the objective
  - e. States SMART measures to track actions and outcomes.
- Review and amend the Zone Committee Action Plan at the beginning of every year to ensure the zone committee is still in agreement with the priority areas and the actions are still those the zone committee believes will achieve their objectives.
- 3. Prepare a Progress Report annually that:
  - Highlights the actions of the zone committee and the progress it has made toward its objectives.
  - Identifies the challenges and opportunities the zone committee see in the coming year.
  - c. Present the report to CWMS partners.
- 4. In developing the Zone Committee Action Plan, the committee must work within and be aligned to the:
  - a. Zone Committee Terms of Reference.
  - b. Canterbury Water Management Strategy and Targets.
- In developing the Zone Committee Action Plan, the committee will also be guided by:

- Committee's Zone Implementation Programme and Zone Implementation Programme Addendum.
- b. Iwi management plans that cover the zone.
- c. Community engagement and feedback.
- d. The triennial 'letter of shared priorities' providing joint direction on priorities for the zone committee from the relevant Territorial Authorities, Environment Canterbury and Rūnanga.

#### LIMITATIONS OF POWER

The Committee does not have the authority to commit any Council to any path or expenditure and its recommendations do not compromise the Council's freedom to deliberate and make decisions.

The Committee does not have the authority to submit on proposed Resource Management or Local Government Plans.

#### COMMITTEE MEMBERSHIP

The committee will comprise:

- One elected member appointed by Waitaki District Council and Mackenzie District Council respectively.
- 2. One elected member appointed by Environment Canterbury.
- One nominated representative from Te Rūnanga o Arowhenua, Te Rūnanga o Waihao, and Te Rūnanga o Mōeraki respectively, with provision for an alternate Rūnanga member to attend zone committee meetings where desired.
- Between 4-7 community members with provision that this number may be exceeded if Waitaki District Council, Mackenzie District Council, and Environment Canterbury agree. Community members are to be appointed in accordance with the process below.
- One youth representative may be added to committee (in addition to the 4-7 community members) on recommendation of the zone committee on a case-bycase basis.
- 6. Where a youth representative is recommended, expressions of interest will be drawn from Environment Canterbury's Youth Rōpū, Waitaki District and Mackenzie District Youth Councils, and Te Rūnanga o Arowhenua, Te Rūnanga o Waihao, and Te Rūnanga o Mōeraki, and confirmed by Waitaki District Council, Mackenzie District Council and Environment Canterbury.
- Waitaki District Council, Mackenzie District Council, and Environment Canterbury will appoint their own representatives on the Committee. Te Rūnanga o Arowhenua, Te Rūnanga o Waihao, and Te Rūnanga o Mōeraki will appoint their representatives and notify Waitaki District Council, Mackenzie District Council and Environment Canterbury.

- 8. Proxies or alternates are not permitted except for Rūnanga representatives.
- Any Committee may co-opt such other expert or advisory members as it deems
  necessary to ensure it's able to achieve it purpose. Any such co-option will be on a
  non-voting basis.

#### SELECTION AND APPOINTMENT OF COMMUNITY MEMBERS

Community representatives are appointed by a panel of CWMS partners – a councillor from each council and a Rūnanga representative from each Rūnanga whose takiwā is within the zone. The panel will be chaired by an Independent Chair.

To be eligible for appointment to a Committee the candidate must live in or be able to demonstrate a significant relationship with the zone.

The process involves:

- 1. A public call for expressions of interest.
- 2. Application
- 3. Interview and/or workshop

Assessment will be based on the:

- · Ability of an applicant to:
  - Work in a collaborative, consensus seeking manner
  - Work with local R

    unanga
  - Establish effective partnerships
  - Understand the complexity of freshwater management issues
  - o Focus on solutions and actions, considering future generations
  - o Understand the CWMS, the vision, principles, and ways of working
  - Demonstrate:
    - Commitment to community
    - Existing community networks
    - Previous experience in a leadership role
    - Experience working with community processes and/or groups
    - Initiate and inspire local action
- The Committee's:
  - Geographic spread of members across the zone
  - o Balance of backgrounds, experience and interests

The selection process above will be primarily focused on appointment of community members to zone committee and may also serve to identify potential future appointees should a community member vacancy arise.

#### QUORUM

The quorum at a meeting consists of:

- Half of the members if the number of members (including vacancies) is even; or
- · A majority of members if the number of members (including vacancies) is odd.

#### CHAIR AND DEPUTY CHAIR

Each year, the committee shall appoint the Chair and Deputy Chair from the membership by simple majority. There is no limit on how long a person can be in either of these positions.

#### TERM OF APPOINTMENT

Members of Committees are appointed for a term of three years, which may be extended on a case-by-case basis if Waitaki District Council, Mackenzie District Council, and Environment Canterbury agree.

Youth members will initially be appointed for a term of one year, with the option to extend their term up to three years subject to availability.

Each Committee requires confirmation of membership by Waitaki District Council, Mackenzie District Council, and Environment Canterbury.

Committee membership refresh will not occur within four months of Local Government elections.

There is no limit on the number of consecutive terms a member may serve.

#### FINANCIAL DELEGATIONS

None.

#### **OPERATING PHILOSOPHY**

The Committee will always operate in accordance with the requirements of the Local Government Official Information and Meetings Act 1987 and Standing Orders of Territorial Authorities.

The Committee will observe the following principles:

- 1. Be culturally sensitive observing Ngāi Tahu tikanga.
- Apply a Ki Uta Ki Tai (from the mountains to the sea) holistic approach that also enables cultural elements including mahinga kai philosophies held by mana whenua to be encompassed.
- Consider and balance the interests of all water interests in the region in debate and decision making.
- Work in a collaborative solution-focused approach using best endeavours to reach solutions that take account of interests of all sectors of the community.
- Contribute knowledge and perspectives but not promote the views or positions of any interest or stakeholder group.
- Promote a philosophy of integrated water management to achieve multiple objectives of the range of interests in water.

7. Seek consensus in decision-making. If neither unanimous agreement can be reached nor a significant majority view formed, in the first instance seek assistance from an external facilitator to further Committee discussions and deliberations. Where the Committee encounters fundamental disagreements, despite having sought assistance and exhausted all avenues to resolve matters, recommend that respective Councils disband them and appoint a new Committee.

#### MEETING AND REMUNERATION GUIDELINES

- The Committee will formally meet at least four times per annum and will hold workshops and host additional community engagement opportunities as required throughout the year. At times, the workload will be substantially higher.
- Remuneration for members will be paid in the form of an honorarium currently set at the following levels:

a. Appointed members \$ 4,000 pa b. Deputy Chair \$ 5,000 pa c. Chair \$ 6,000 pa

- 3. An expert or adviser who has been co-opted on to the committee is eligible for an honorarium at the same rate as an appointed member.
- 4. Staff or elected members of Territorial Authorities or Environment Canterbury are not eligible for remuneration.
- Mileage will be reimbursed.

#### COMMITTEE SUPPORT

The committee shall be supported by staff from the Territorial Authority and Environment Canterbury, primarily through the Committee Secretary and the Zone Facilitator and senior staff member from relevant Territorial Authority and Zone Manager/Lead from Environment Canterbury.

#### Our role:

Grow support and resources to achieve the goal of five mahinga kai projects.

#### Ecosystem health and biodiversity targets

- Gaining insight into cultural values and areas of significance relating to mahinga kai
- Engaging with schools and youth to illustrate the importance of mahinga kai and the local history
- Increasing engagement with Ngãi Tahu regarding enhancement of Nohoanga sites
- Recommending biodiversity funding with a priority focus on mahinga kai sites
- Improving understanding of Te Tiriti o Waitangi
- Hosting hängi for stakeholders and local schools.

#### We will commit to the improved management and preservation of recreational values of the Waitaki Lakes by:

- · Supporting and enhancing our Love Our Lakes Campaign
- Engaging with agencies, catchment groups and stakeholders to enhance and protect recreational areas such as the Twizel River and Lake Ruataniwha
- Educating the community about how to protect our environment through actions such as responsible toilet use.

#### We will support catchment groups taking collective action to reduce losses of contaminants, prioritised where they are addressing identified at-risk areas by:

- Exploring opportunities to partner with key community groups who are focused on waterways, such as the Ahuriri Catchment Community Group.
- Supporting establishment of new catchment groups and build on what is already on the ground in the community
- Requesting bi-annual reports from Environment Canterbury on Farm Environment Plan audit results and consenting follow-up and sharing this information with relevant catchments
- Requesting briefings from Environment Canterbury on the state of our water resources and results from monitoring and sharing with relevant catchments.

## We will communicate and engage with our communities by:

- Investigating additional channels for sharing the Zone Committee story within local townships around the Upper Waitaki zone
- Increasing engagement with local community boards, such as Tekapo Community Board, and discussing opportunities for collaboration
- Developing and maintaining relationships with industry, rūnanga, councils, and catchment groups to be an intermediary for when community members need advice
- · Sharing and celebrating successes.
