BACKGROUND

The Council at its meeting on 14 September 2021 formally adopted the Mobile Shops and Traders Bylaw 2021 – Statement of Proposal for formal consultation pursuant to section 83 of the Local Government Act 2002 (LGA).

The Statement of Proposal and Proposed Bylaw were released for formal consultation, in accordance with the Special Consultative Procedure set out in the LGA, on 20 September 2021. The submission period closed on Friday 22 October 2021.

SUBMISSIONS

In total eight submissions were received on the Proposed Bylaw. One submission was received late. The submissions were received either by email or the Let's Talk Platform.

A summary of the submissions is provided in Appendix 1.

HEARING OF SUBMISSIONS

Of the submissions received four submitters requested to be heard in support of their submission. The purpose of this meeting is for the Council to formally receive the eight submissions outlined in Appendix 1 and 2 and to hear from those parties who wish to be heard in support of their submission. A timeline for the hearing of submissions is provided in Table 1.

These decisions will be published in a decision document which Council will be asked to adopt at a following meeting. Any required changes will also be made to the Proposed Bylaw with the final Bylaw to be formally adopted by Council at its meeting on 16 November 2021.

- That persons who present their views are given access to a clear record of the decision making.

SIGNIFICANE OF DECISION

The Proposed Mobile Shops and Traders Bylaw 2021 is subject to the Special Consultative Procedure as directed by the LGA and triggers Mackenzie District Councils Significance and Engagement Policy.

- That the Council formally receive the eight submissions to the Proposed Mobile Shops and Traders Bylaw and hears submissions from four submitters who wish to be heard in support of their submission.
- 2) That the Council receive those views with an open mind and give them due consideration.
- 3) That the Council consider and deliberate on the submissions received and make any necessary decisions on the Proposed Mobile Shops and Traders Bylaw.

Submission:

Mobile traders and shops by law: 2021

The Shot NZ Ltd requests consideration to carry our mobile trading within the Mackenzie District Council region

The activities that we are applying for approval to carry out are the supply of hot and cold beverage to the public on demand.

This activity requires the Shot Mobile van to be parked at the road way curb side and serve to the public who in all cases are standing on a grass verge/foot path or possible a driveway that crosses between the road way and property.

The activity is normally short term and to use an example much as similar to a mobile ice cream vendor who parks and serves to the public and then moves onto another location.

The duration of the park in most cases would not exceed 15 minutes and depended on how many hot beverage serves are to be completed.

All care is taken to park legally and safety of the public and the Shot operator is a 100% full consideration practiced.

In seeking this approval we must empathise that the Shot mobile operators do not park anywhere near a café or similar business selling take out drinks (Café, Service station, Restaurant, etc.).

Most our business activity is completed at the request of the owner of the property to supply services and conducted on private property. We are requested to supply refreshments at business houses, schools, rest homes, factories and manufacturing operations for example).

We also provide rubbish receptacles and remove any discarded packaging from the park area.

The requirements as laid out by the Council areas we are trading in are fully compliant with including holding a mobile trading licence and are compliant with all MPI requirements. The Shot NZ trades at NP1 level.

The Shot NZ mobile vans are fully compliant to NZ standards (Gas fitters and electrical WOF on hand for inspection at any time).

Outline for submission

At the Outset, Hospitality has been the most challenged trade with the aftermath of COVID-19. Businesses have been affected with more than 50% drop in sales/ revenues and as a business owner I would expect flexibility from the local bodies / Council and its members that shape the futures of this industry in one of the worst affected regions of New Zealand.

My particular interest is addressing items that would potentially cause us financial strain or impact our day to day operations.

The rules outlined in the new proposal in Schedule 2 under the subtitle, Signage and Rubbish are of particular concern.

After working with the South Canterbury Chamber of Commerce by availing grants for Marketing & Business Continuity Planning, suggestions were made by Skylark Creative, Twizel and Sidekick CA, Timaru to upgrade **Signage** and get new flags, posters etc to increase visibility of our business. We spent NZD 250 per flag and ordered 6 new flags. If the new schedule were to be accepted we stand to lose money on all these when the total area of the flag is only 1.08 square metres (approximately). How would this new rule justify our spend when on one side the demand by government approved service providers is to reduce costs and overheads and the bylaw points at "reinventing the wheel".

Will the approval from the council for signage attract any fees?

As far as the **Rubbish bins** are concerned, the issue was brought up in the meeting of Board Members in Tekapo about 2 years ago. If mobile traders are classified as "Takeaway" outlets where people purchase food or other goods

and go away, isn't the matter of Rubbish Bins redundant and an extra cost center?

In a DELTA and plus COVID-19 environment, where people travelling could potentially be infected, isn't handling rubbish that comes back from a contaminated source an extra hassle we don't require as mobile traders? This would put families of Mobile Traders at risk of any future contamination and potential business closure / hibernation.

Maintenance of Site

This has been excluded from a list of items that could otherwise cause maintenance issues for Vehicles of the Mobile Operators. For Example, I have personally reported the waterlogging of Our trading site on Denmark Greens in Fairlie after days of bad weather including Rain, Frost & Snow. Under the circumstances, where the Council is worried about level playing field, would the Councillors consider taking the onus to solve an issue so basic?

Permanent but Not Permanent licensing

The tone of the email mentions that the licensing and bylaws aim at more of a permanent stature of Mobile traders but there still has to be yearly renewals. How is this permanent? We recently paid for a full 12 month renewal in August but I have been advised that the new bylaws will take effect in December 2021. Would the Council consider crediting the balance on to a new renewal term / license?

Yes, I would like to address Councillors in person at a hearing. Please inform me as requested in the beginning of this email.

I urge the Council to take an example from Dunedin, Wanaka, Queenstown, Christchurch and other places where Mobile traders can operate with more liberty and thrive, even during difficult times.

Dear Sir/Madam,

Despite the timeline expiring, I wish to make a further submission to the proposed Trading Byelaws in respect to Twizel.

The area currently set aside and being retained in the proposal is related to food vendors only.

There is however another sector that should have provision for an area to be set aside. And that is for non-food vendors. The original (and ongoing thinking) was for competing mobile food vendors to be separated from fixed premises trading.

At the moment there is not an area for non-food vendors such as pop-up trade stalls (such as one a few days ago by a tool retailer) or temporary activities.

I suggest the tarmac area opposite the machinery display on Wairepo Road in Twizel where there is plenty of room, parking included. I attach a photo of an activity mockup that I set up myself.

I trust that due consideration can be given to my proposal.
